GENERAL DESCRIPTION OF SERVICES BEING ACQUIRED: One (1) customized, **Trade-Based Money Laundering (TBML)** training for up to 30 officials of the Government of Panama. The training will consist of two (2) modules, as described in the Work Statement.

Module 1: To be provided on June or July, 2021, Monday to Friday. It will consist of three (3) hours of presentation (synchronous activity) and one (1) hour of daily asynchronous activity, for a total of forty (40) hours.

Module 2: Will be onsite at Panama City, Republic of Panama, for one 40-hour week, Monday through Friday on July or August, 2021.

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is to for the provision of TRADE-BASED MONEY LAUNDERING (TBML) TRAINING, in accordance with Section 1.
- B. The contract will be for 80 hours period from the date of the contract award.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. *The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.*

2. STANDARD. *The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.*

3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. General

The Bureau of International Narcotics and Law Enforcement Affairs (INL) requires the services of an international or local consulting organization to provide one (1) customized, **Trade-Based Money Laundering (TBML)** training for up to 30 officials of the Government of Panama. The training will consist of two (2) modules.

Participants would be prosecutors from Public Ministry, investigators from the National Police (DIJ) and IMELCF, Judge from the Judiciary Branch, and supervisory and legal affairs officials from the Internal Revenue Directorate (DGI), Financial Analysis Unit (UAF), TTU and TCIU units.

2. Background

The U.S. Department of State is supporting the Public Ministry as part of an on-going, long-term AML capacity building between the U.S. and Panamanian Governments in order to assist Panama to investigate, detect, deter, prevent, and mitigate illicit financing activities in Panama and reduce its effects on both the Panamanian and the U.S. financial systems.

3. Scope of Services

The scope of services for this project is as follows, as implemented by a consultant or trainer of the Contractor:

A. Introduction/Background

The Financial Action Task Force (FATF) placed Panama on its grey list of jurisdictions subject to ongoing monitoring in June 2019. In this order of ideas, FAFT has recommended, among other actions: To implement an inter-institutional training model that allows the different actors in the criminal prosecution system to understand how a money laundry investigation is conducted in an accusatory criminal system and the prosecutors must be strengthened and trained in order to increase the effectiveness of the identification, seizing and confiscation of assets in the implemented accusatory criminal justice system and to mitigate inexperience with non-drug-related money investigations and prosecutions.

Panama agreed to an Action Plan with concrete measures to be completed in stages through September 2020 in order to be removed from the FATF grey list. Among the Action Plan items, Panama must increase effectiveness of the AML regime.

B. Objectives

Train participants in:

- International Trade-Based Money Laundering (TBML) Overview.
- Typologies in Panama.

- Methodology of Forensic Investigations on TBML.
- Investigation of Illicit Flows
- Interagency and International Collaboration.

C. Scope of Work

The Contractor will deliver training including interactive lectures, group exercises, and a final assessment of participants.

D. Training Conditions

- The first virtual two (2) weeks training (Module 1) will be on June or July, 2021, Monday to Friday. It will consist of three (3) hours of presentation (synchronous activity) and one (1) hour of daily asynchronous activity, for a total of forty (40) hours.
- The second training (Module 2) will be onsite at Panama City for one 40-hour week, Monday through Friday on July or August, 2021.
- Regarding points 1 and 2, training and materials must be in Spanish.
- Regarding point 3, didactic material is any resource that facilitates the acquisition of knowledge, abilities and skills; such as bibliographic or infographic references, brochures, ppt presentations, videos, practical cases, among others.

4. Performance Site

- The first two (2) week virtual training (Module 1) between June and July, 2021, Monday through Friday. It will consist of three (3) hours of presentation (synchronous activity) and one (1) hour of daily asynchronous activity, for a total of forty (40) hours. For which the Consultant will provide a virtual platform suitable for synchronous and asynchronous activities.
- The second training (Module 2) will be onsite at Panama City, during one forty (40) hour week, Monday through Friday, on July or August, 2021. The Consultant will provide a hotel conference room or training center in Panama City, with a food court and / or restaurants no more than 100 meters away from the site. The conference area must have the necessary equipment and implements for the development of training; and parking services for each participant during the training days. In addition, the Consultant will provide each day a time for lunch for the participants and will offer two refreshments, one in the morning and another in the afternoon.
- The hotel or selected training center must comply with the biosafety measures established by the Panamanian authorities and in force at the time of the event.

5. Requirements

- The Consultant must sign a confidentiality agreement.
- The Consultant must provide all participants with useful printed course material.

- The Consultant must provide all participants with electronic copies of the presentation material within seven days of completion of training.
- The Consultant must provide certificates of completion to participants.
- A virtual platform suitable for scheduled synchronous and asynchronous activities.
- The hotel or selected training center must comply with current biosafety measures established by Panamanian authorities.
- The Consultant will plan, manage and execute the training program, from its inception to its completion, and maintain a physical presence for the duration of training.
- The Consultant will allow the contracting party to review the academic program content, the content of the slides and didactic training resource at least three (3) weeks prior to the training date and will consider mutually agreeable edits to the training in advance of the training.
- Any change before the training about the consultant or representatives subject matter expert(s) of the consultants presented in the offer, must comply at least with the require qualifications and will need previous approve from U.S. Embassy (and/or INL).

6. Qualifications

- At least two (2) Subject Matter Experts (SME) of the Consultant must have minimum five consecutive years of relevant, comprehensive professional experience in designing and delivering local and international trainings on Trade-Based Money Laundering (TBML).
- At least two (2) Subject Matter Experts (SME) of the Consultant must have minimum five consecutive years of relevant, comprehensive professional experience as prosecutor, investigator, intelligence agent or similar activity focused on the prosecution and/or investigation of Trade-Based Money Laundering (TBML) or Money Laundering, in general.
- At least one (1) Subject Matter Expert (SME) of the Consultant must have minimum five consecutive years of relevant, comprehensive professional experience on private sector focused on Law Enforcement, application of Anti-Money Laundering policies or similar.
- The SME of the consultant will be fluent in the Spanish language, written, read and spoken.
- Consultant shall have organized, led, or conducted trainings in Trade-Based Money Laundering (TBML) in at least three countries in Latin America (geographically from Mexico to Chile) including Panama.
- Minimum two (2) Subject Matter Experts (SME) of the Consultant must possess at least certifications from an internationally recognized AML training organization and risk training organization.
- Consultant shall have experience providing **Trade-Based Money Laundering (TBML)** training to governments.

- Consultant shall perform all activities needed to prepare for and conduct the training including reaching out to the place before the training. Also include prepare by itself study cases for training.
- Panama based company familiar with Panamanian laws/regulations and local cases.

 - (ii) One or more United States persons have the authority to control all substantial decisions of the trust.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

- (2) Discriminating in the award of subcontracts on the basis of religion.
