GENERAL DESCRIPTION OF SERVICES BEING ACQUIRED: Three training events, on Anti-Corruption for officials of the Government of Panama as described in the Work Statement.

PERIOD OF PERFORMANCE: The training will be in virtual mode during the months of June, August, and October 2021 with a duration of 40 hours per week for each course from Monday to Friday, as follows:

- 40 hours Virtual Training on Crimes Against Public Administration for 25 participants on the month of June, 2021.
- 40 hours Virtual Training on Crimes Against Public Administration for 25 participants on the month of August, 2021.
- 40 hours Virtual Training on Crimes Against Public Administration for 25 participants on the month of October, 2021.

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is to for the provision of ANTI-CORRUPTION TRAINING COURSES, in accordance with Section 1.
- B. The contract will be for 120 hours period from the date of the contract award.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

**1. SURVEILLANCE.** *The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.*

**2. STANDARD.** *The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.*

**3. PROCEDURES.**

*(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.*

*(b) The COR will complete appropriate documentation to record the complaint.*

*(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.*

*(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.*

*(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.*

*(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.*

*(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.*

*(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]*

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

**1. OVERVIEW**

The Bureau of International Narcotics and Law Enforcement Affairs (INL) requires the services of an international consulting organization for the provision of three virtual courses on crimes against public administration to the detriment of the Panamanian State for 25 prosecutors of the Public Prosecutor's Office of Panama.

**2. BACKGROUND**

The U.S. Department of State is supporting the Government of Panama in building criminal justice capacity to combat crime against the public administration that affect the national economy.

**3. SCOPE OF SERVICES**

The scope of services required for this project is to include international recognized experts (consultants or trainers) with the knowledge and, as well, the legal and investigative experience in crimes involving acts of corruption against public administration, especially in the modality of embezzlement, corruption, and fraud in acts of public contracting and its connection with money laundering and its presentation in the courts of justice.

**3.1. Introduction / background.**

The Republic of Panama does not escape the phenomenon of corruption that plagues Latin American countries. In spite of the fact that the country is a signatory of the Inter-American Convention against Corruption, the United Nations Convention against Corruption and the Convention against Transnational Organized Crime, which contains a catalog of criminal conducts that imply acts of corruption, the 2020 reports of international organizations such as Transparency International, point to Panama among the most corrupt countries in the region, together with the scandals for public corruption crimes, which in recent years has placed the country in the international community's spotlight.

In this regard, justice institutions are concerned about not having the necessary competencies to identify, investigate and punish these behaviors, which currently involve complex typologies, requiring justice operators to update and strengthen their skills, abilities, and capacities to minimize perceived impunity and raise conviction standards.

**3.2. Objectives**

To train participants to:

- 3.2.1.** Identify acts of corruption against public administration in the context of the Criminal Code, special laws and international conventions and their connection with the crime of money laundering emphasizing the modalities of embezzlement, corruption, and fraud in public contracting.



- 3.2.2. Harmonize the roles and functions of administrative institutions in public contracting and accounts with the roles and functions of the Public Prosecutor's Office in the prosecution and investigation of acts of corruption.
- 3.2.3. Strengthen competencies for the presentation of crimes against public administration before the Courts of Justice.

### **3.3. Scope of Work**

The Contractor shall provide virtual training that includes interactive lectures, group activities and a final assessment of the participants, over a period of 40 hours for each course.

### **3.4. Training Conditions**

The training will be in virtual mode during the months of June, August, and October 2021 with a duration of 40 hours per week for each course from Monday to Friday.

The training and materials provided to the participants must be delivered in Spanish.

Training materials are defined as any resource that facilitates the acquisition of knowledge, skills, and abilities, such as bibliographic or infographic references, brochures, ppt slides, videos, case studies, among others.

At least 80% of the speakers must be international with high experience in the educational field, investigation, and domestic and international criminal laws on anti-corruption.

## **4. VENUE**

The contractor will provide from his/her own country, for each course, the technological platform adjusted to provide e-learning education to 25 prosecutors of the Public Prosecutor's Office of the Republic of Panama, including synchronous meetings between participants and trainers.

## **5. CONDITIONS**

- 5.1. The contractor shall sign a non-disclosure agreement.
- 5.2. The contractor shall provide all participants with useful and quality material in electronic format for the development of the course.
- 5.3. The contractor must provide all participants with electronic copies of the presentation material within seven days of the completion of the training.
- 5.4. The contractor must provide certificates of completion to participants.
- 5.5. A virtual platform suitable for synchronous and asynchronous activities.
- 5.6. The contractor shall perform all logistical activities necessary for the planning, management, and execution of the training program from its commencement to its completion and ensure the presence of all selected trainers during synchronous presentations.
- 5.7. The Contractor shall allow the contracting party to review the content of the training program and the learning resources for the training at least two weeks prior to the date of the training, which shall be sent electronically.

## **6. QUALIFICATIONS**

- 6.1. The contractor must have at least five consecutive years of professional experience in the design, planning and organization of domestic and international training programs.
- 6.2. The contractor shall be fluent in the Spanish language, written, read, and spoken.
- 6.3. The contractor shall have organized, supervised, or conducted training in international and domestic anti-corruption policies.
- 6.4. The contractor must have at least five years of experience in the development of virtual higher level academic programs.
- 6.5. The contractor must have advanced and specialized academic background that guarantees knowledge in Panamanian criminal legislation on conducts that according to Panamanian legislation involve acts of corruption, international instruments related to crimes involving acts of corruption to the detriment of the public administration and its connectivity with money laundering.

## **7. DELIVERABLES**

The consultant must submit the following documents:

- 7.1. The work plan for the development of three courses of the virtual training duly detailed with the methodology, schedule of activities indicating dates and milestones to be provided.
- 7.2. Academic program for the development of the three training courses in virtual modality.
- 7.3. The academic program shall contain a thematic and analytical guide for each course, including the learning resources to be used.
- 7.4. The thematic guide and the training shall develop the following areas and topics:

### **7.4.1.COURSE 1**

- Public Procurement Law
- Fraud in public procurement acts
- Structure of the indictment
- Role of the criminal jurisdiction in crimes against public administration vs. the court of auditors' jurisdiction.

### **7.4.2.COURSE 2**

- Embezzlement and Corruption
- Modalities for committing money laundering
- Role of the financial institutions in times of a pandemic
- Criminal liability of legal persons

### **7.4.3.COURSE 3**

- Techniques on interviewing
- Argumentation of criminal resources
- Plea bargaining agreement techniques

- 7.5. Certificates issued for participants with 100% attendance.
- 7.6. Evaluation of participants' knowledge at the beginning and at the end of the training.
- 7.7. Evaluation of the impact of the training in the workplace and professional environment.
- 7.8. Recordings of the daily synchronous sessions at the end of the training and sending them to the participants.

Any other day designated by Federal law, Executive Order, or Presidential Proclamation.

(b) When New Year's Day, Independence Day, Veterans Day or Christmas Day falls on a Sunday, the following Monday is observed; if it falls on Saturday the preceding Friday is observed. Observance of such days by Government personnel shall not be cause for additional period of performance or entitlement to compensation except as set forth in the contract. If the contractor's personnel work on a holiday, no form of holiday or other premium compensation will be reimbursed either as a direct or indirect cost, unless authorized pursuant to an overtime clause elsewhere in this contract.

(c) When the Department of State grants administrative leave to its Government employees, assigned contractor personnel in Government facilities shall also be dismissed. - (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern*—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in [38 U.S.C. 101\(2\)](#), with a disability that is service connected, as defined in [38 U.S.C. 101\(16\)](#).

*Small business concern—*

(1) Means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR part 121 and size standards in this solicitation.

52.229-11 Tax on Certain Foreign Procurements—Notice and Representation (JUN 2020)

(a) *Definitions.* As used in this provision—

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It  is  is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14  a full exemption, or  partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. - (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
