I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is to procure a CASE MANAGEMENT SYSTEM in accordance with Section 1.
- B. The contract will be for a one-year period from the date of the contract award.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

- [1. **SURVEILLANCE.** *The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.*
- 2. **STANDARD.** *The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.*

3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

General

The Bureau of International Narcotics and Law Enforcement Affairs (INL) requires the services of a company with worldwide expertise on case management software for the Government of Panama.

Officials using the system would be investigators from the National Police (DIJ), prosecutors from Public Ministry, supervisory and legal affairs officials from the Internal Revenue Directorate (DGI), Financial Analysis Unit (UAF), and Superintendency of Banks.

Background

The U.S. Department of State is supporting the National Police (anti-money laundry unit of DIJ), the Public Ministry, DGI (Panamanian IRS-Style Agency), UAF (Panamanian FinCEN-Style Agency) and the Superintendency of Banks as part of an on-going, long-term AML capacity building for the AML Task Force between the U.S. and Panamanian Governments in order to assist Panama to detect, deter, prevent, and mitigate illicit financing activities in Panama and reduce its effects on both the Panamanian and the U.S. financial systems, so as to ensure compliance with FATF to be removed from their list.

Scope of Services

The scope of services for this project is as follows:

A. Introduction/Background

The LEGATT-sponsored Panamanian Anti money laundering Task Force is an emergent US-Panamanian government initiative. It is a high priority bilateral initiative which was formally approved by Panama's President and a senior US National Security Council representative visiting Panama City in September 2020. The LEGATT-sponsored Panamanian Anti money laundering Task Force was scheduled to start operations in October 2020.

This request aims at ensuring compatibility between systems used by US Government and Government of Panama. The Kaseware System or equal, should be a cloud-based case and document system for investigators, compatible with Sentinel, a US Government system by FBI. If another software different is used or competed at this point, it may result in additional costs and effort, delays or a limited assistance by FBI; as this group will have to learn a new system, the Task Force or FBI may have to manually input data or would face other difficulties when trying to exchange information between the two groups.

B. Objectives

To get a case management system as Kaseware or equal identified as meeting requirements for interface and functionality similar to FBI systems, capacity to import bulk data files and generate analytical reports exportable to existing US and Panamanian government systems which meets availability for an expedited delivery date on or about June.

C. Scope of Work

The Kaseware or equal case management system must provide the required capacity to import bulk data files and generate analytical reports, the ability to ingest a variety of datasets, to include financial records, that could be integrated into the case database and used to inform complex comparative and tracing analyses, ongoing customer service and robust support, to include database customization, user training, and long-term system maintenance.

D. Conditions for the Provision of the Service

It should be an FBI-grade Case management system with tools designed to enhance investigation efficiency, effectiveness and safety. With graphing features, such as Network Graph and timelines, that help the user organize data by event type, identity, business, social media, or other related data points with No client-side installation required (OS Agnostic), easy escalation and flexibility capability.

Place of Performance

It should be delivered and installed in the premises of the AML/AC Task Force, Panama City, Republic of Panama.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(i) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible website the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

(ii) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose a quantitative greenhouse gas emissions reduction goal, i.e., make available on a publicly accessible website a target to reduce absolute emissions or emissions intensity by a specific quantity or percentage.

Add the following provision:

52.229-11 Tax on Certain Foreign Procurements—Notice and Representation (JUN 2020)

(a) *Definitions*. As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations.
