• PROJECT DESCRIPTION:

The project consists of the underground and roof tank cleaning at operating lease residences owned by US embassy. The estimated nos. of houses where the tank is to be cleaned is 55.

Contractor shall provide a manpower and equipment details capable of cleaning

1334500 Liters of water tanks. Awarded vendor should have sufficient manpower as

Required by US embassy to carry out this work.

Statement of Works

Underground water tank (cemented - masonry)

- 1. Remove infected water from tank by pumping out remaining water to nearest storm drain line.
- 2. When personnel are working within a water tank all "Confined Space" safety measures must be applied. Work inside any confined space is labeled as high-risk activity by U.S. Department of State. During the proposal submission, bidder must submit detail Safety Plan for Confined Space Entry for working inside the Water Reservoir Tank that will also address Emergency Action Plan for unforeseen accidents that can occur inside the tank. After the project is awarded,

the Contractor shall prepare and submit an Activity Hazard Analysis (AHA) two weeks prior to the start of work. Details are provided in the SAFETY Section.

- Contractor must provide a Portable Ventilation Blower, Tripod with lifting mechanism and a fall harness at site for emergency rescue while working inside water tanks.
- All employees of the Contractor must attend the Safety Orientation provided by the POSHO-Assistant before starting this project.
- Contractor must provide required Personal Protective Equipment (PPEs) including Fall Harness/Safety Belt to each employee working inside the tank.
- Contractor must provide pre-job training to all their employees. They must know contractor's Safety Plan and hazards associated with working inside the tank.
- Contractor shall refer to attached documents while preparing **Safety Plan for** * * * **Confined Space Entry** (see Section 2: Attachments)
 - OSHA's Confined Spaces
 - ➤ DoS/OBO/SHEM's Confined Space Program Procedures
- 3. Remove remaining sediments and sludge with suction machine to eliminate all dirt and sediments settled in the floor of the tank
- 4. Manually clean all parts of the tank with brush, cloths and fresh water
- 5. Empty the tank again after cleaning is completed
- 6. Mop the floor and make it dry
- 7. Add 10 liters of Chorine and fill it with water of 5000 liters for tank sanitizing
- 8. Keep the chlorinated water for 1-2 hours and pump the chlorinated water to the roof tanks. Make sure before pumping the water, the roof tanks are empty and cleaned.
- 9. Flush all the water pipeline inside and outside the building.
- 10. Fill the fresh water in the underground tank in presence of US Embassy water treatment staff and take a sample at a tap inside the building for analysis in an approved city-based lab.
- 11. Make sure to cover the tanks properly, confirming proper seal.
- 12. Report of water from lab to be submitted to the COR.

Rooftop/plastic (polyethylene, polypropylene) water tank

- 1. Switch off the system.
- 2. Remove all water from tank
- 3. Manually clean tank floor with brush, cloths and fresh water
- 4. Remove remaining sediments and sludge with suction machine
- 5. Add 1 liters of Chorine and fill it with water of 500 liters for tank sanitizing and keep it for half an hour and then flush it through water pipes and fixtures of the building.
- 6. Replace the roof tank cover if it's broken. Roof tank cover will be provided by U S government.

7. Finally fill the fresh water in the underground tank in presence of US Embassy water treatment staff and take a sample at a tap inside the building for analysis in an approved city-based lab.

Parameters of water to be tested after tank cleaning:

- 1. pH
- 2. Turbidity
- 3. Iron
- 4. Total Alkalinity
- 5. Lead
- 6. Arsenic
- 7. Manganese.

Tank cleaning plan: The following requirements shall be incorporated into the Contractor's water tank cleaning Plan and followed in the field. The plan shall include, but shall not be limited to, a discussion of the following:

- Description of tank cleaning methods and procedures, including any temporary air used during the entire tank cleaning works.
- Time required to clean both the underground and roof tank per liter.
- Description of quality control procedures to be used for placement of air blower while work is carried out in the underground tank.
- Description of contamination prevention in the tank and decontamination procedures.
- Description of specific methods to be employed to disperse the water in the tank before it is cleaned.

Contractor technical qualification and submission requirements:

The Contractor shall provide the following technical information when presenting the Bid Package to demonstrate his capacity to do the work and this information will be evaluated in the Bid Review Process by the Contracting Officer.

The minimum necessary information will be:

- Provide list of equipment available to perform multiple tank cleaning in a day which includes Air Blower, Tripod, 2HP submersible pump, Safety equipment & Fall harness, halogen lamp, ladders.
- Numbers of trained manpower in water tank cleaning that the contractor can provide in a day.
- Contractor capacity to clean water tank simultaneously based on available manpower and equipment.
- Contractor capability to clean water tanks of capacity 150,000 liters.
- Provide reference letter of minimum 3 years of experience in water tank cleaning works only.
- Provide working methodology on water tank cleaning and sanitizing works.
- Safety Plan for Confined Space Entry
- Comply with all the Contractual legal and administrative requirements outlined in the bid package provided by the Embassy contracting office such as contractor's general information, capacity to provide Liability Insurance as detailed in the package.

 Work Schedule & Working Methodology: The contractor shall submit work schedule and commencement copy alongside the bid package for the execution of work and also detailed working methodology and emergency safety plan intended for this cleaning process.

PROJECT SCHEDULE

- Contractor should provide proposed work schedule and time frame to Embassy during submission of proposal.
- Work hours will be from 08:00am to 17:00pm, Monday through Friday at different operating leased houses.

SELECTION CRITERIA

- Contractors will be selected based upon their prior work experiences of minimum 3 years in water tank cleaning works only, of capacity 150,000 liters or above. Contractor should provide reference letter of water tank cleaning works only.
- Contractor must provide these equipment (Air Blower, Tripod, 2HP sump pump). Air Blower, Tripod and 2 HP sump pump actual pictures, specifications must be enclosed while submitting Bid.
- Contractor should follow American Water Works Association (AWWA) or equivalent guidelines while cleaning and sanitizing the water tanks.

PAYMENT PROCESS

- Contractors will be paid according to the percentage of work completed on timely basis upon submission of the bill. US government will not provide advance payment as well as material in site requests.
- Payment will be made 3-4 weeks after the submission of the bill. VAT shall be charged as applicable.

GENERAL SPECIFICAITON OF WORKS:

Once contractor receives and accepts awarded contract, contractor will furnish a within seven (7) days from issue of signed contract.

The COR or the Government Technical Monitor (GTM) will ensure contractor provided material are not damaged prior to or during installation and that standard industry practices, as defined by local Building Codes, are followed at all times.

Contractor will provide finish surface protection.

Final inspection will be held with the COR and the Contractor representative assigned to inspect quality and completion prior to final customer acceptance and approvals.

SAFETY:

- COR or GTM will ensure that all equipment used during the project is in safe operating condition.
- COR or GTM reserves the right to stop the work if any unsafe contractor conditions are observed or encountered.

Basic safety rules while working inside water tanks:

• Possible Hazards: Oxygen deficiency from rusting metal, decay of organic matter, poor ventilation; engulfment by water, and electrocution.

- Contractor must submit **Confined Space Entry Permit** for each water tanks prior to entry for all properties. Contractor shall not enter the confined space without prior approval from FM/POSHO. (see Section 2: Attachments)
- Contractor must have following materials before working inside the water tank:
 - o Straight Ladder
 - o Flashlights
 - o PPE: Full body fall harness/safety belt with lanyard, rubber gloves, rain boots, masks, etc.
 - o Cleaning materials and bucket etc.
 - o Sump Pump
 - Extension cable drum
 - o Portable ventilation blower
 - o Tripod with lifting mechanism
 - High pressure washer.
- Use ventilation equipment, like portable ventilation blower, before entry into water tank. Ventilate before entry and continue ventilation during entry.
- Use ladder to enter/exit the water tank.
- Contractor must wear rain boots while entering the tank. Bare foot is not allowed.
- Sump pump should always be connected to power outlet or extension cable drum with 10mA GFCI/ELCB to prevent any electrocution to workers inside the tank.
- All electrical devices must have ground cables installed. Cables should be free from cuts and defects.
- There should be an attendant present outside the tank while cleaning work is ongoing.
- Personnel working on a roof, without any railing or fall protection, must wear a safety belt/full body harness along with a lanyard.
- Contractor should submit a written emergency plan to rescue a person trapped inside a water tank.
- A "Safety Plan" must be submitted by the Contractor after contract is awarded but prior to the commencement of work. The Contractor should be solely responsible for risk assessments, managing health, safety and environmental issues associated with this project. The POSHO and/or APOSHO will review and approve the Contractor's Safety Plan.
- The Contractor shall prepare and include an **Activity Hazard Analysis (AHA)** in the Safety Plan, for all high-hazard work, prior to the start of work (e.g., welding, lifting of materials in bulk, connection of high-voltage wiring, etc.). The contractor must document how the hazard controls will be implemented and maintained during the project. POSHO and/or A-POSHO will review and approve the Contractor's AHA. The AHA may also be referred to, or known as, the Job Hazard Analysis (JHA). A comprehensive AHA or separate AHA for each job may be submitted.

as sources of minimum standards for the safety and health to be used/employed during/throughout this project.

- The Contractor shall be responsible for conducting the work in a manner that ensures the safety of its employees and USG employees/personnel at the project site during the entire project.
- The Contractor shall be responsible for any mishaps, injuries or accidents which occur during the project. Any mishaps and near misses involving the contractor's employees must be reported to the COR within 24 hours. The COR will report all incidents to the POSHO and APOSHO.
- employee **Personal Protective Equipment (PPE)** that will protect the employee from hazards. At a minimum PPE should consist of safety glasses and/or goggles for eye protection, hard hats for head protection, appropriate gloves, and closed-toe shoes. Closed shoes with steel toe are mandatory for employees using power actuated tools (e.g., a jack hammer, pick for excavation, axe for cutting trees, and for work that requires lifting heavy materials, etc.). Sandals or athletic shoes are not acceptable. PPE such as gloves, dust masks, earplugs, hard hats, safety shoes, and coveralls and face shields are recommended for contracted personnel. These items must be provided at the Contractor's expense. All contractor personnel shall wear PPEs as identified in the Safety Plan, and/or deemed necessary by the COR, FM/POSHO or A-POSHO.
- Workers may use discretion if they feel unsafe in using the equipment.
- The Contractor must not create an unsafe or hostile work environment for its personnel.
- Any worker at an elevated and unprotected location above 1.8 meters (6 feet), with the exception of a portable ladder or balcony with railings, must be provided and utilize a **safety harness with lanyard**. These items must be in good condition and free from cuts and damages.
- **Scaffoldings** should be provided by Contractors for working at heights where ladder use is unsafe. Full body fall harness with lanyard should also be used by the Contractor. Bamboo scaffolding is not allowed to be used at USG leased residences. The Contractor will use only COR and/or POSHO/APOSHO approved metal scaffoldings with platforms and bracing.
- **Welders** must have proper PPE: welding goggles/mask, leather gloves, apron or welding jacket that is fire rated. **Fire Watch** with dedicated fire extinguisher should be on the vicinity of work site. Fire curtain should be used not to expose welding sparks to others. Contractor must obtain Embassy's **Hot Work Permit**

before commencing any **hot work** (cutting, grinding, welding). Hot work equipment must be in good condition. Fire safe materials will be placed under any welding or hot work to protect the surface under the work and prevent ignition of surfaces.

- The Contractor must follow **Embassy's Confined Space Program and Entry Procedures** and obtain **Post Approved Confined Space (PACS) Permit** before entering any confined space: underground/above ground water tanks, and manholes. The Contractor needs to coordinate with the COR to receive this permit.
- **Safe Electrical Work Practices:** The Contractor must follow safe electrical work practices to prevent electric shock, arc flash, or other injuries resulting from either direct or indirect contact with electrical circuits or equipment which are or may be energized.
 - o Work de-energized. Use Lock-Out/Tag-Out (LO/TO) while working on energized equipment/circuit. Inform all other affected personnel.
 - O All electrical equipment such as drilling machines, welding machines, portable grinders, power strips, and electrical extension cords must be in good working condition, properly grounded, and be free from any cuts/defects on/in the insulation cover. Three pin plugs shall be used instead of live wires when plugging into any power outlets.
 - Correctly connect electrical wires with the wire caps (also known as wire nuts) and do not use only electrical tape to make electrical bonds.
 - Use 10mA Ground Fault Circuit Breakers (GFCIs) on power outlets/extension cable drums while working outdoors or in wet areas.
 - Use wooden or fiber ladders instead of metal ladders while working on electrical circuits.
- Respiratory Protection: Approved respirator mask (half face/full face) shall be used while performing work that produces toxic organic vapors. Before work may proceed, the contractor must obtain approval from the COR of the written safety plan required by FAR 52.236-13, Accident Prevention Alternate I (see paragraph (f) of this clause), containing specific hazard mitigation and control techniques.
 - (1) Scaffolding;
 - (2) Work at heights above 1.8 meters;
 - (3) Trenching or other excavation greater than one (1) meter in depth;
 - (4) Earth-moving equipment and other large vehicles;
 - (5) Cranes and rigging;
 - (6) Welding or cutting and other hot work;
 - (7) Partial or total demolition of a structure;
- (8) Temporary wiring, use of portable electric tools, or other recognized electrical hazards. Temporary wiring and portable electric tools require the use of a ground fault circuit interrupter (GFCI) in the affected circuits; other electrical hazards may also require the use of a GFCI;
- (9) Work in confined spaces (limited exits, potential for oxygen less than 19.5 percent or combustible atmosphere, potential for solid or liquid engulfment, or other hazards considered to be immediately dangerous to life or health such as water tanks, transformer vaults, sewers, cisterns, etc.);
- (10) Hazardous materials—a material with a physical or health hazard including but not limited to, flammable, explosive, corrosive, toxic, reactive or unstable, or any operations, which creates any kind of contamination inside an occupied building such as dust from demolition activities, paints, solvents, etc.; or

- (11) Hazardous noise levels as required in EM 385-1 Section 5B or local standards if more restrictive.
- (b) Safety and health requirements. The contractor and all subcontractors shall comply with the latest edition of the U.S. Army Corps of Engineers Safety and Health manual EM 385-1-1, or OSHA 29 CFR part 1910 or 1926 if no EM 385-1-1 requirements are applicable, and the accepted contractor's written safety program.
- (c) *Mishap reporting*. The contractor is required to report *immediately* all mishaps to the COR and the contracting officer. A "mishap" is any event causing injury, disease or illness, death, material loss or property damage, or incident causing environmental contamination. The mishap reporting requirement shall include fires, explosions, hazardous materials contamination, and other similar incidents that may threaten people, property, and equipment.
- (d) *Records*. The contractor shall maintain an accurate record on all mishaps incident to work performed under this contract resulting in death, traumatic injury, occupational disease, or damage to or theft of property, materials, supplies, or equipment. The contractor shall report this data in the manner prescribed by the contracting officer.
- (e) *Subcontracts*. The Contractor shall insert this clause, including this paragraph (e), with appropriate changes in the designation of the parties, in subcontracts.
- (f) Written program. The plan required by paragraph (f)(1) of the clause entitled "Accident Prevention Alternate I" shall be known as the Site Safety and Health Plan (SSHP) and shall address any activities listed in paragraph (a) of this clause, or as otherwise required by the contracting officer/COR.
- (1) The SSHP shall be submitted at least 10 working days prior to commencing any activity at the site.
- (2) The plan must address developing Activity Hazard Analysis (AHAs) for specific tasks. The AHAs shall define the activities being performed and identify the work sequences, the specific anticipated hazards, site conditions, equipment, materials, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level of risk. Work shall not begin until the AHA for the work activity has been accepted by the COR and discussed with all engaged in the activity, including the Contractor, subcontractor(s), and Government on-site representatives.
- (3) The names of the Competent/Qualified Person(s) required for a particular activity (for example, excavations, scaffolding, fall protection, other activities as specified by EM 385-1-1) shall be identified and included in the AHA. Proof of their competency/qualification shall be submitted to the contracting officer or COR for acceptance prior to the start of that work activity. The AHA shall be reviewed and modified as necessary to address changing site conditions, operations, or change of competent/qualified person(s).
